Leadership Training Internet Governance for Persons with Disabilities in Pakistan 26-28 December 2023

Executive Summary

The Disability Leadership Training on Internet Governance for Persons with Disabilities in Pakistan, conducted from December 26 to December 28, 2023, at the Ramada Hotel Islamabad, was a landmark event organized by Pathfinder Solutions in partnership with the Internet Society Accessibility Standing Group and the Pakistan Telecommunication Authority (PTA).

The workshop aimed to empower individuals with disabilities to become leaders in advocating for accessibility, digital rights, and fostering an inclusive Internet governance landscape. A diverse group of 20 participants, including those with visual, physical, hearing and cerebral palsy impairments, engaged in a highly interactive program covering key topics such as internet governance, key stakeholders, accessibility, privacy and cybersecurity, opportunities in Internet Governance, Pakistan's digital ecosystem, and the role of individuals with disabilities in shaping internet governance policies.

The event took place at the accessible venue of the Ramada Hotel Islamabad, with sign language interpreters and assistants ensuring the inclusivity of all participants. The workshop's success was attributed to seamless logistical arrangements, including travel support, accommodation, and stipends for participants from various regions.

The Chairman of PTA as the Chief Guest at the certificate award ceremony, added distinction to the event. The workshop's findings emphasized the importance of continued efforts to empower individuals with disabilities, and recommendations include the continuation and expansion of similar training programs, forging partnerships, enhancing outreach strategies, and integrating more hands-on activities.

Introduction:

The Path Finder Solutions (Private) Limited, in collaboration with the Pakistan Telecommunication Authority (PTA) and the Internet Society Accessibility Standing Group, successfully organized a groundbreaking Leadership Training on Internet Governance for persons with disabilities in Pakistan from December 26 to December 28, 2023, at the Ramada Hotel Islamabad. This training initiative was the first ever national level training for persons with disabilities in the internet governance domain.

Background:

The Asia-Pacific School on Internet Governance (APSIG) in partnership with the Internet Society Accessibility Standing Group organized a train the trainer workshop on Leadership Training on Internet Governance and Digital Rights for Persons with Disabilities from June 24th to 28th 2022 in Dhaka, Bangladesh. This initiative aimed to build the leadership capacities of South Asian disability advocates in Internet governance and transfer these skills to their own countries through the organizing of national workshops. Dr. Muhammad Shabbir, the Chief Executive of Path Finder Solutions, participated in Dhaka workshop as facilitator and a participant.¹

At Path Finder Solutions, we believe that technology should be accessible to everyone at the same time and at no additional cost, regardless of impairment or ability. By working towards our mission and objectives, we are striving towards a more inclusive and equal society for all. Our team is dedicated to making a difference in the lives of people with disabilities by empowering them with accessible technology. We envision a world where individuals with disabilities have equal access to technology, opportunities, and resources, enabling them to achieve their full potential. Our mission is to empower people with disabilities through accessible technology solutions and resources. We aim to conduct cutting-edge research on accessibility, provide web/digital accessibility audits and solutions, conduct training in accessibility, and promote low-cost accessibility solutions for the developing world.

Building upon the success of the Dhaka workshop, Path Finder Solutions conducted a face-to-face workshop in Islamabad, Pakistan with the support of Internet Society Accessibility Standing Group and Pakistan Telecommunication Authority. The workshop included Dr. Muhammad Shabbir as the organizer and resource person, along with other experts in the field.

General Overview:

The workshop aimed to empower individuals with disabilities to become leaders in advocating for accessibility, digital rights, and fostering an inclusive Internet governance landscape. It brought together 21 participants, including 12 visually impaired, 5 physically impaired, 3 deaf / hard of hearing, and 1 with double disability (physical and cognitive). There were 12 male and 9 female participants, representing various regions of Pakistan, including: Rawalpindi/Islamabad, Lahore, Abbottabad, Faisalabad, Karachi, Gilgit-Baltistan, and Quetta. Thus, there was a good balance of disability, gender and geographic diversity in terms of participant's selection for the training. Due to the time constraints, there was no advertisement or call for applications. However, key people and organizations were approached to take part as well as some requests were received when the word went out that such a training was being organized. the final selection of the participants was made by Dr. Muhammad Shabbir keeping in view the aforementioned balance. One female participant dropped due to health reasons. The list of successful participants is at annexure-1.

The first day of training program commenced with the recitation of the Holy Quran, followed by a warm welcome from Dr. Muhammad Shabbir, CEO of Path Finder Solutions; video message from Gunela Astbrink, Chair of the ISOC Accessibility Standing Group; and the participants introduction. The day progressed with sessions covering the introduction to Internet Governance, key stakeholders, leadership skills, digital accessibility standards, and advocacy techniques. The day concluded with a summary of day 1 and a preview of Day 2.

Sessions on the second day delved into topics such as privacy and digital security, Pakistan's digital ecosystem, internet fellowships and grants, funding proposals, showcasing accessibility solutions, and discussions on digital accessibility policies and the Right to Information landscape in Pakistan. The day ended with a summary and a glimpse of the agenda for the final day.

The last day featured feedback and future commitments by the participants, a debate on digital accessibility in Pakistan, and the closing ceremony. This included remarks by Naveed Haq from the Internet Society, distribution of shields and certificates, remarks by Dr. Muhammad Shabbir, and an address by the Chief Guest, Maj. Gen. (R) Hafeez Ur Rehman, Chairman PTA. The detailed program is at annexure-2.

Venue:

The choice of the Ramada Hotel Islamabad provided a conducive and accessible environment for all participants. While the conference venue was fully accessible, it's noted that the hotel had limited rooms with wheelchair facilities.

Accessibility Measures:

To ensure inclusivity, the organizers engaged the services of sign language interpreters and male and female assistants to facilitate participants throughout the workshop.

Logistics:

Logistical arrangements, including registration processes, provision of materials, and technical support, were executed seamlessly. The hotel staff and the organizing team's collaborative efforts ensured smooth operations throughout the workshop.

Special Guests:

Pathfinder Solutions extended an invitation to the Chairman of PTA to be the Chief Guest at the certificate award ceremony, adding a distinguished touch to the event. The certificate award ceremony was widely covered in print media. Annexure-3 carries a list of links of some of the news reports. Picture Gallery offers some glimpses of the workshop.

Findings:

The workshop facilitated in-depth discussions on crucial topics such as digital accessibility, Internet governance policies, and advocacy skills. Participants actively engaged in practical exercises, group discussions, and knowledge-sharing sessions. The key findings include:

- a. Internet Governance is a very vast field and there are very few persons with disabilities contributing in it.
- b. There are number of opportunities for individuals and organizations to collaborate, engage and advocate in the IG domain. Persons with disabilities and their organizations in Pakistan should actively contribute in those discussions.
- c. The participants of this leadership training were willing to also organize in person trainings or online sessions on IG and digital accessibility for persons with disabilities in their respective cities and organizations.
- d. Participants now have a heightened awareness of available funding opportunities, fellowships, and grants in the field of IG. This knowledge positions them to secure resources for their projects, ensuring sustainability and scalability of their efforts.
- e. The training has deepened participants' understanding of local digital accessibility policies and the Right to Information landscape in Pakistan. This awareness ensures that advocacy efforts align with national regulations, facilitating a more effective and strategic approach.
- f. There is a need to foster partnerships with industry stakeholders, tech companies, and organizations dedicated to accessibility. Collaborations with these entities can provide resources, mentorship, and opportunities for participants to implement and scale their accessibility solutions.
- g. The continuation and expansion of similar training programs, forging partnerships with relevant organizations, enhancing outreach strategies, and integrating more hands-on activities into future workshops is recommended.

Next Steps:

The sessions on third day were designed to gain participants' feedback on the training, their future commitments and strategies for the next steps. It was reiterated that all the successful participants of the workshop will write individual reports outlining their key learnings from the training and how they planned to implement those learnings. The participants reports (unedited) are linked with this report and can be accessed by clicking on the name of the participant in Annexure-1.

In his remarks during the certificate award ceremony, Dr Muhammad Shabbir on behalf of the training participants proposed some measures to Chairman PTA for implementation. The Chairman assured that his office will exercise his powers to implement these recommendations and also invited Dr. Muhammad Shabbir for more discussion on these recommendations in his office at PTA. The recommendations are as following:

- 1. Instruct PTA's web development team to make its websites and online systems such as DIRBS accessible to WCAG2.1 AA level standards for persons with disabilities. Moreover, consider the inclusion of persons with disabilities in PTA's gender inclusion and child online protection programs.
- 2. Instruct telcos and ISPs to make their websites and applications accessible to WCAG2.1 AA standards for persons with disabilities and establish mechanisms to ensure that these standards are maintained as content is updated.
- 3. Encourage telcos and ISPs to provide special low-cost internet and call packages for persons with disabilities through their CSR programs, facilitating their communication needs.
- 4. Recommend, as a board member to USF, that the Universal Service Fund should be leveraged to facilitate digital connectivity for persons with disabilities and enable them to access low-cost digital devices.
- 5. Advise the Ministry of Information Technology and Telecommunication (MOITT) to establish a proper mechanism ensuring the accessibility of all public sector websites for persons with disabilities.
- 6. Suggest to MOITT that, based on the principle of 'nothing about us without us,' every public consultation should include the input of persons with disabilities.

Conclusion:

To conclude, the Disability Leadership Training on Internet Governance has not only imparted knowledge but has also ignited a spark of empowerment, collaboration, and advocacy. This journey commenced with a vision — a vision to empower individuals with disabilities to become leaders in advocating for digital rights. The principle of "nothing about us without us" echoed in every aspect of this workshop. This program is a testament to the belief that true change is driven by the very individuals it seeks to empower. It is about the voices of those directly affected being at the forefront of advocacy and leadership. The participants, now equipped with enhanced skills and networks, are poised to lead the charge for a more inclusive and accessible digital landscape in Pakistan and beyond. The impact of this training extends beyond the workshop, laying the foundation for positive change in the digital realm.
